### Event Rules and Regulations

- All arrangements for rented space at the event are to be made through the Wall St. Antiques Treasure Hunters Expo.
- Spaces will be assigned upon registration with deposit. **NO SPACES WILL BE HELD WITHOUT DEPOSIT.** For your convenience, we accept Visa, MasterCard, Amex & Discover or your personal check/money order.
- We will accommodate booth placement requests whenever possible, but reserve the right to place/relocate the booth at our discretion.
- Booths using electricity must provide extension cords. We advise bringing a minimum of 50' in length.
- Booth displays must be positioned as to not impede aisle traffic, cause a safety hazard, obstruct areas that must meet fire code, or infringe upon another booth space or endanger another person's merchandise.
- Booth displays are to be contained within the boundaries assigned.
- Merchandise for sale must consist of primarily old or vintage items. **No new merchandise** will be allowed. All items must be pre-owned, **no wholesale/retail merchandise** will be allowed. Overall representation of any booth must at all times represent quality and all items must be accurately represented. Promoter reserves the right to ask dealer to modify or remove their merchandise if promoter deems it is not consistent with the theme or quality of the show.
- We ask that each person associated with your booth behave in a respectful and professional manner, with propriety and self-control. Please refrain from using profanity. Please be aware that failure to comply may lead to dismissal from the show.
- Wall St. Antiques Treasure Hunters Expo and Midland County are the authoritative bodies responsible for management of the event and insuring that everyone complies with the above rules and regulations.
- By signing this agreement, you grant permission for the use of images from your booth (including any motion picture or still photographs made by the promoter) for any purposes in connection with promoting the event, which may include but is not limited to advertising, promotion and marketing. The promoter may crop, alter or modify/combine such images with other images, text and graphics, without notification.
- Sales Tax: Tax rate is 8.25%. All **businesses** renting a space must have an active Texas sales tax permit number. Certain requirements/permits for selling in the state of Texas may be required. Promoter may be required to supply dealer participation information, including but not limited to, registered name, address and phone number to the State of Texas or other governing authorities at the conclusion of the event. Sales tax collected is submitted by dealer directly to State of Texas.
- Cancellation policy: Deposits are non-refundable.
